- Ripon Area School District Community Survey
  (Staff note: The school district is exploring options regarding their facilities study and would like to know which options the community prefers.
  Superintendent Mary Whitrock and school board members will share a proposed community survey with the Council on Tuesday evening.)
- Resolution writing off certain ambulance accounts deemed uncollectible (Staff note: Periodically, staff brings forward a list of the delinquent ambulance accounts deemed uncollectible, after reviewing them with the City Attorney to make sure all reasonable collection efforts have been made. Staff recommends approval of the attached resolution writing these off of our accounting records.)

- 3. Report of the Board of Canvassers certifying results of the April 1<sup>st</sup> election (Staff note: The report from the Board of Canvassers summarizing the results of the April 1<sup>st</sup> municipal election will be on your desks Tuesday evening for your review and approval.)
- 4. Request for street closure Ripon Medical Center (RC2 Run)
  (Staff note: The Ripon Medical Center is seeking permission to close Seward Street from Woodside to Watson Street on Saturday, May 3<sup>rd</sup> from 5:00 a.m. to 12:00 p.m., as well as parking restrictions the evening before, in conjunction with its annual RC2 run. Staff has no objections or concerns, and recommends approval subject to receiving a certificate of insurance and hold harmless agreement.)
- 5. Request for street closure Ultimate Frisbee Tournament on April 12<sup>th</sup> (Phi Kappa Pi fraternity) (Staff note: As outlined in the attached letter from Vice President Quinn Mischler, Phi Kappa Pi requests closure of Congress Street from Elm to Locust on April 12<sup>th</sup> from 10:00 a.m. to 6:30 p.m. for an ultimate Frisbee tournament. Staff has no objection to the request, and recommends barricades be set up west of the private drive for the house at the intersection of Elm and Congress on Congress St. and that the organizers be respectful of those people's property rights as well.)

Certificate of Appropriateness Application (Staff note: At their 4/2 meeting the Historic Preservation Commission will be making a recommendation regarding the Certificate of Appropriateness Application from Boca Grande Capital, LLC regarding the demolition of the fire damaged structures at 310 and 312 Watson Street. The Commission's recommendation will be on your desks Tuesday evening for your review and approval.)
